No commercial products allowed in this show. The show coordinator reserves the right to limit the number of duplicate crafts. **We ask you to please send a picture with your application.**

8'x10' space: Spring Market \$75 + tax, Holiday Market \$125 + tax, BOOKING DISCOUNT: BOTH Spring & Holiday Market \$175 + tax (Please specify on your application if you need electricity where indicated)

6'x4'no electricity: Spring Market \$45 + tax, Holiday Market \$65 + tax, BOOKING DISCOUNT: BOTH Spring & Holiday Market \$100 + tax (We have a few of these available)

Please NOTE: Vendor must purchase both spaces of the same size for the Spring & Holiday Market before April 1,2017 to qualify for the booking discount.

Table rental (8' table): \$10 + tax

Please bring all of the set up that you will need to accommodate you space including tables (unless renting from us), extension cords and display pieces. There will be no separators between each space so plan accordingly. "Gifts.Well Crafted" reserves the right to assign vendor space. Space will be assigned on a First come-first served basis so please get your application in as soon as possible.

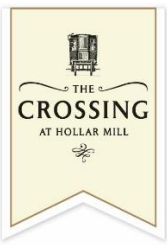
